1. Contribution groups and service level

The members are divided into contribution groups. The amount of the fee for full members from the IT providers and IT users from the economy depends on the annual turnover of the company / institution and the number of employees. The change to the next higher contribution level if BOTH criteria that are specified in the higher level apply.

Startups and existing members with an annual turnover of less than ϵ 250,000 can apply to the board of directors until the end of the period following the application pay a reduced fee of ϵ 441 each calendar year.

Cities and municipalities below 100,000 inhabitants, universities and professorships and honorary members are exempt from the

Cities and municipalities below 100,000 inhabitants, universities and professorships and honorary members are exempt from the obligation to contribute - however a payment is possible any time. IT providers and IT users from business and scientific institutes Can choose between three service packages. The contents of the service packages are shown on page 2 of these fee regulations.

2. Sustaining members

Sustaining members can be natural persons who want to support the work of the association financially and in terms of content with their membership. He or she can take part in the general assembly, but are not entitled to vote. The same applies to honorary members. The board of directors can support members due to continuous special contributions to the association's work, nominate them as full members with votting rights in exceptional cases upon request.

These must be confirmed by the members in the general meeting.

3. Fees for new members and for the first year and in the context of a merger

In the first year of membership, new members are granted an entry-level discount of 50% on the membership fee. Should a member join in the last three months of a year, membership is free until the end of the year and the entry discount is granted for the following year.

For members who have joined the OSB Alliance - Federal Association for Digital Sovereignty e.V. due to a merger with another association the membership fees of the transferring association apply for the current financial year in which the merger takes effect. From then on the membership fees of the OSB Alliance must be paid in the following financial year.

4. Exceptions

The board of directors is authorized to allow exceptions to the fee regulations in special cases.

5. Supporting contributions

In addition to their membership fees, members can support the OSB Alliance - Federal Association for Digital Sovereignty e.V. with additional funding. These funding contributions are made without earmarking and without consideration and cannot be offset Against the membership fees.
